WAIVER OF LIABILITY AND RELEASE AND INDEMNIFICATION AGREEMENT

I, _____, hereby request the opportunity to participate in the Road-E-O Program sponsored by the SWANA Lone Star Chapter ("sponsor") at Dallas, Texas on May 14th, 2010.

WHEREAS, the Solid Waste Association of North America and the Sponsor, their respective agents, employees and officers (hereinafter referred to as "SWANA") consents and agrees to permit _____ (hereinafter referred to as "PARTICIPANT"), to participate in the Road-E-O program, subject to the adherence of the PARTICIPANT to any provisions set out in the rules and regulations of SWANA and to the terms and conditions below herein.

NOW, THEREFORE, for and in consideration of the premises and the mutual promises, covenants, and agreements set forth in this Agreement, SWANA and PARTICIPANT agree that SWANA, its agents or employees, shall not be liable or responsible for, and shall be SAVED, HELD HARMLESS, RELEASED and INDEMNIFIED by PARTICIPANT from and against any and all suits, actions, losses, damages, claims, or liability of any character, type, or description, including but not limited to all expenses of litigation, court costs, and attorney fees for injury or death to any person, or injury to any property received or sustained by any person or persons or property arising out of, or occasioned by, directly or indirectly, the participation of PARTICIPANT in the Road-E-O Program, including claims and damages arising in whole or in part from the negligence or SWANA, its agents or employees.

IT IS THE EXPRESS INTENT OF THE PARTIES TO THIS AGREEMENT THAT THE INDEMNITY PROVIDED FOR IN THIS AGREEMENT IS AN INDEMNITY EXTENDED BY PARTICIPANT TO INDEMNIFY AND PROTECT SWANA FROM ANY AND ALL CLAIMS OR ACTIONS, AS SET FORTH ABOVE, OF ANY KIND, ARISING DIRECTLY OR INDIRECTLY FROM THE PARTICIPATION OF PARTICIPANT IN THE ROAD-E-O PROGRAM, REGARDLESS OF WHETHER SUCH CLAIMS OR ACTIONS ARE FOUNDED IN WHOLE OR IN PART UPON THE ALLEGED NEGLIGENCE OF SWANA, ITS REPRESENTATIVES, AGENTS OR EMPLOYEES.

It is further understood and agreed that the PARTICIPANT will participate solely as an individual on a voluntary basis and not as an employee, contractor or agent of SWANA or its agents or employees. Individuals who are employed by SWANA acknowledge that this participation is outside the scope of their employment and is performed on a voluntary basis only.

In making this Agreement, PARTICIPANT relies wholly upon his/her own judgment, belief and knowledge and has not been influenced to any extent whatsoever by any representations or statements not contained in this Agreement.

I understand that participation in the Road-E-O Program involves certain inherent risks and potential hazards which I have considered and which I knowingly assume.

I have read this Waiver of Liability and Release and Indemnity Agreement, and fully understand all of its terms. I understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

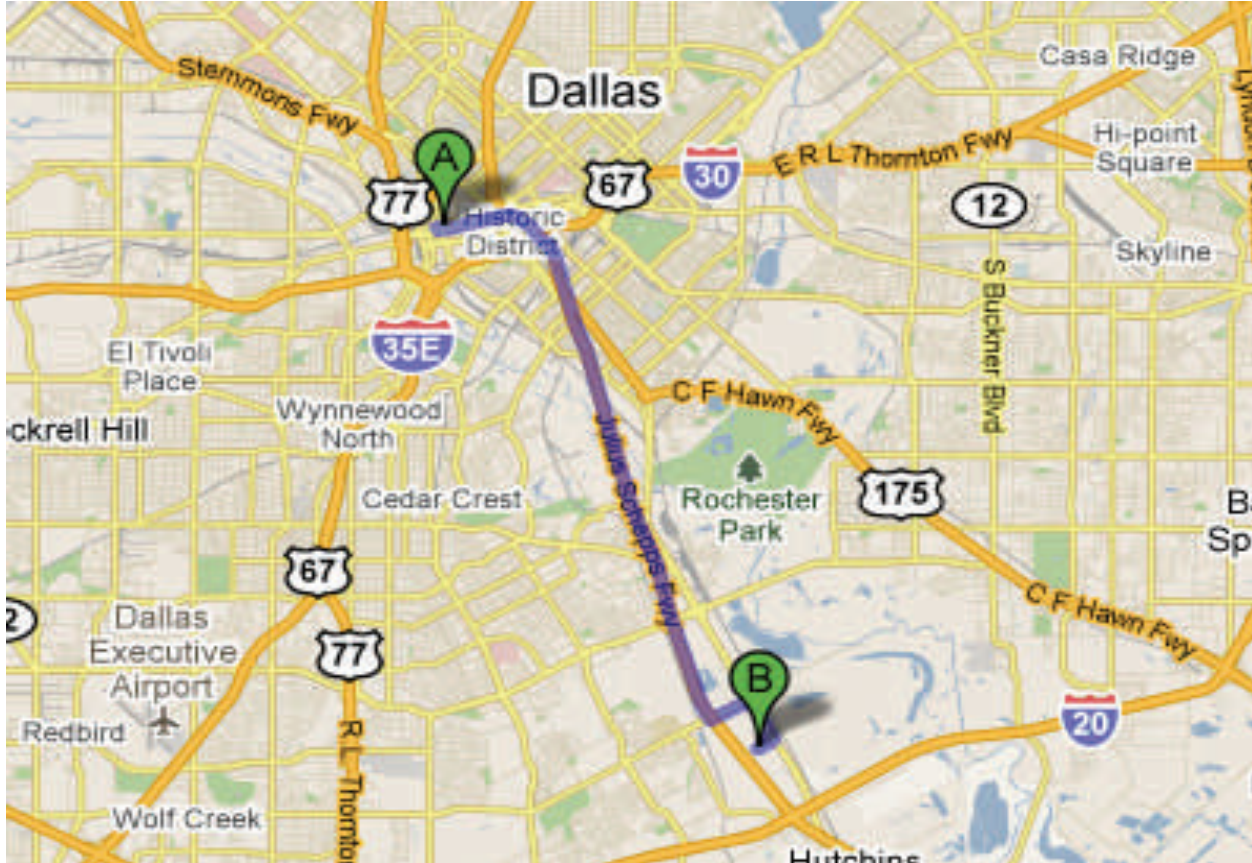

4. Turn **SLIGHT LEFT** to take the **I-45 S** ramp toward **1-30.**
5. Merge onto **I-45 S** toward **HOUSTON.**
6. Take the **SIMPSON STUART RD** exit, **EXIT 277.**
7. Turn **LEFT** onto **SIMPSON STUART RD.**
8. Turn **RIGHT** onto **S CENTRAL EXPY / TX-310 S.**
9. Turn **RIGHT** onto **YOUNGBLOOD RD.**
10. **5100 YOUNGBLOOD RD** is on the **LEFT.**
